REASONABLE ACCOMMODATIONS

We have received many calls about reasonable accommodations in the last several months.

To request a reasonable accommodation (RA) due to a disability, a participant must qualify as an individual with a disability under the following definition of disability

- Have a physical or mental impairment that limits one or more of the major life activities (e.g. working, learning, eating, moving, etc.) of an individual
- Have a record of such impairment; or
- Be regarded as having such

an impairment.

The PHA will fully comply with the obligations found in HUD Notices PIH 2010-26 (HA) and PIH 2006-13 (HA) [Non-Discrimination and Accessibility Notice: Section 504 of the Rehabilitation Act of 1973; the American with Disabilities Act; the Architectural Barriers Act of 1968 and the Fair Housing Act of 1988].

SHRA has a brochure at their management offices that explains the process and there is a request form that may be sent to your doctor to fill out and forward it to the RA committee for determination.

More information about the RA application and process may be found in the ACOP (Admissions and Continued Occupancy Policy)

RAD UPDATES

SHRA is expecting to wrap up construction on RAD 2 in November with all residents back in their units.

Beginning in 2022, SB 1383 requires every jurisdiction to provide organic waste collection services to all residents and businesses.
